Announce and Adopt the 2025/2026 Millage Rate:

Commissioner Gatewood made a motion to accept Resolution 2025-003, which sets the proposed millage rate at 3.5 Mills, for fiscal year 2025-2026. Seconded by Commissioner Mere. There were no questions. The motion was put to vote, and the vote was 5-0. (1)

Presentation of 2025-2026 Tentative Budget:
